Medical Establishment: Physicians 1660-1837

The physicians to the person and the physicians to the household were both appointed by lord chamberlain's warrant. During the reign of Charles II their appointments were embodied in letters patent under the great seal.

Usually there were four physicians to the person. In 1685 they were ranked by number and given graduated salaries of £400, £300, £250 and £219 (later £200).¹ This arrangement continued in principle until the death of Anne in 1714. On the accession of George I in that year only one physician, Shadwell, was appointed who was nevertheless designated first physician and accorded a salary of £400.² In due course two more physicians were appointed during the reign. On the accession of George II in 1727 the number was again fixed at four each with a salary of £300.³ Early in the period, physicians were also allowed riding wages and, often, lodgings.

It was the practice for extra physicians to the person to be appointed.

Two physicians to the household served from 1660 to 1667 and one thereafter except during the years 1702-16 when the office was left vacant. The salary was £200.⁴

Surgeons 1660-1837

The sergeant surgeons, surgeon to the person and surgeon to the household were appointed by lord chamberlain's warrant. As a general rule the appointments of the sergeant surgeons were

embodied in letters patent under the great seal.

Originally three in number, the sergeant surgeons were reduced to one in 1685. A second was appointed in 1743 and thereafter the number was fixed at two except in 1760-73, 1776-86 and 1809-18 when it rose to three. The remuneration originally consisted of wages of £80, board wages of £140 and an annuity of £150 making a total of £370.¹ In 1685 it was fixed at £369 13s 4d² and in 1689 at £396 13s 4d.³

The office of surgeon to the person did not have a continuous existence being left vacant from 1701 to 1715 and from 1743 to 1821. The remuneration consisted of wages of £40, board wages of £127 15s and a pension of £150 making a total of £317 15s.⁴

It was the practice for extra surgeons to the person to be appointed.

The remuneration of the surgeon to the household consisted of wages of £40, board wages of £140 and a pension of £100 making a total of £280.⁵ Early in the period, all surgeons were also allowed riding wages and, sometimes, lodgings.

One or two extra surgeons to the household served from 1784.

Apothecaries 1660-1837

The apothecaries to the person and the apothecaries to the household were both appointed by lord chamberlain's warrant. In many cases appointments were embodied in letters patent under the great seal.¹

Originally there was one apothecary to the person. Two served from 1685 to 1820 when the number was again reduced to one. The remuneration attached to the offices varied from time to time. In 1660 the sole apothecary received £242 15s consisting of a salary of £115 and board wages of £127 15s.² In 1685 both apothecaries were granted salaries of £500.³ In 1702 one apothecary received £372 5s and the other £327.⁴ By 1711-12 the salaries had been fixed at £320 5s and £160.⁵

The office of apothecary to the household was held singly until 1727. Thereafter it was usually held jointly, two occupants serving 1727-62, three 1762-6 and two 1766-74, 1774-83 and from 1820. Originally the remuneration amounted to £100 consisting of wages of £40 and board wages of £60.⁶ In 1702 the salary was £160.⁷ By 1711-12 it had been fixed at £106 13s 4d.⁸ early in the period, all apothecaries were allowed riding wages and, sometimes, lodgings.

Chemist 1660-1837

The chemist and chemical physician were appointed by the lord chamberlain. Under Charles II the chemical physician made £20 per annum while the apothecary and operator in chemistry made £131 17 s.¹ Under Charles II and again under George I the chemist received £100 per annum at the office of the treasurer of the chamber. By that of George III, his remuneration had fallen to £45 14s 0 3/4d. The position was abolished in 1782² and revived (?without regular payment) in 1820.

Artistic Establishment: Poet Laureate 1660-1837

The poet laureate was expected to produce annual odes in praise of the Sovereign for his birthday and New Years' Day as well as other, similar panegyrics as occasion demanded. This office appears originally to have been in the gift of the Crown which made appointments by letters patent under the great seal granting the office during pleasure.¹ During the tenure of John Dryden and Thomas Shadwell (1668-92) the office was combined with that of historiographer. Thereafter the two offices were held separately. Nahum Tate was the last holder of the office to be appointed by letters patent; subsequent appointments were made by lord chamberlain's warrant. The salary, fixed at £200 in 1670, was reduced to £100 in 1692. In addition, the poet laureate was allowed an annual butt of sack or £30 in lieu thereof²

Historiographer c.1662-1782, c.1807-1837

The earliest holder of this office is said to have been James Howell. In 1662 he was granted an annuity of £200 by letters patent under the great seal which make no mention of the office.¹ However, in the letters patent granting the combined offices of historiographer and poet laureate successively to John Dryden (1670) and Thomas Shadwell (1689) Howell is mentioned as one of their predecessors. Dryden's salary was £200 while Shadwell's was £300.² Thereafter the two offices were held separately and the historiographer's salary was fixed at £200. Thomas Rymer was the last holder of the office to be appointed by letters patent in 1692; subsequent appointments were made by lord chamberlain's warrant. The office was abolished in 1782.³ It had, however, been revived by 1807.⁴

Librarians 1660-1837

Between 1660 and 1837 the care of the various royal libraries gave rise to the existence of four distinct offices.

At the Restoration in 1660 Thomas Ross was appointed keeper of the royal libraries.¹ In 1665 he was granted the office for life by letters patent under the great seal² and this course was followed for subsequent appointments. The office ceased to have any substantive existence in 1757 when George II gave the contents of the libraries to the British Museum. However, Claudius Amyand, the last keeper, continued to enjoy the title and the remuneration until his death in 1774.³ A salary of £200 payable at the Exchequer was attached to the office in 1661.⁴ From 1747 an additional allowance of £100 in lieu of accommodation was paid.⁵

In 1760 George III appointed a separate librarian with a salary of £200 to care for his own collection of books which came to be located at Buckingham Palace. When this was, in its turn, given to the British Museum in 1823 this office ceased to have any functions although its holder, Sir Frederick Barnard, appears to have retained the title until his death in 1830.

In 1814 the office of librarian at Carlton House was created⁶ and continued to exist after the dispersal of the contents of that house in 1826. Finally a librarian at Windsor Castle was appointed in 1836.⁷

This officer was appointed by lord chamberlain's warrant. The earlier designations 'Purveyor and Keeper' and later 'Repairer' were only gradually superseded by that of 'Surveyor' of the pictures.¹ The salary, originally £100, had been raised to £200 by 1694.²

Principal Painter 1660-1837

Appointments to this office were, as a general rule, made by lord chamberlain's warrant. In 1660 Lely was appointed 'Limner and Picture Drawer', being succeeded in 1681 by Riley as 'Painter and Picture Drawer'.¹ In 1684 Verrio, appointed exceptionally by royal warrant, was designated 'Chief First Painter'.² From 1689 'Principal Painter' was the recognized description of the office.³ The salary, originally £200, was reduced to £50 in 1782.⁴ In addition, this officer received a gold chain and medal.⁵

Master of the Music 1660-1837

Also known under Charles II as master of the king's violins, the master of the music was appointed by lord chamberlain's warrant.¹ In addition to administering the various royal musicians, he was also responsible for composing, 'fair writing and pricking' royal birthday and New Year's odes when no other musician had been given the commission.² Prior to 1782, he received a salary of £200 from the treasurer of the chamber. By that date, he also received £25 for writing the annual ode for the King's birthday and £39 6s for the musical preparations for that event (and the same again for the Queen's birthday). Prior to the appointment of a separate conductor of music he received £100 for this service.³ By the end of the period, he held for life at a salary of £265 plus fees of honor.⁴

This officer was called the 'assistant master of music' in 1765. The conductor of music made £100 from 1787 to the end of the period. By the end of the period, he held for life.¹

Musicians 1660-1837

At the beginning of the period, the royal musicians played on great ceremonial occasions such as New Year's Day and royal birthdays; and also, in smaller groups, for court balls and theatricals; at the King's dinner, and, under Charles II only, in accompaniment to the Sunday services of the chapel royal.

Musicians were appointed by the lord chamberlain, usually by warrants to the gentleman usher daily waiter.¹ Under Charles II, some musicians held their places by patent for life and pay varied widely from musician to musician (the standard fee seems to have been £46 10s 10d or 12s 8d). That pay was usually in arrears, often for years at a time. There were separate consorts for the twenty-four violins; the wind band; the broken consort; the private music for lutes, voices, theorbos and virginals and the French and Italian musics. Favored individuals could hold multiple positions in one band or several, irrespective of their instrumental specialty.² In 1685, the life tenures were abolished and these consorts were consolidated into one consisting of thirty-three players and vocalists and one instrument keeper paid £40 per annum plus £16 2s 6d for livery apiece, called the 'Private Music'. (For purposes of the following list and the personal index, however, musicians heretofore members of one of these consorts reappointed to the consolidated band in 1685 are dubbed simply 'Musician').³ Musicians were also allowed 3s per diem in riding wages.⁴ In 1689 the number of musicians rose to thirty-nine, including eight vocalists and three composers, but on 2 May 1690 the band was reduced to twenty-four, which remained its established number for the remainder of the period. From that date, William III also maintained a separate establishment of eight vocalists. By the end of the period, pay rose to £45 14s plus fees.⁵

By the mid-eighteenth century, places in the band of 24 musicians were frequently awarded as sinecures to non-musicians and the court came increasingly to rely upon a private ensemble, paid out of the privy purse, for its musical entertainment. In 1815 the Treasury requested an inquiry into the state of the band, 'it appearing extremely desirable that this Band should if continued upon the Establishment be rendered efficient.' By 1841 there were just thirteen efficient members of the band.⁶

The composer for the violins made £200, that for the private music made £40 paid at the Exchequer.⁷

The Italian musicians received chains with medals.⁸

Sergeant Trumpeter 1660-1837

The sergeant trumpeter regulated not only the trumpeters in ordinary, but all trumpets, fifes and drums in the country as a whole. Often, the holder was not a musician.¹ He was appointed by the lord chamberlain and held his place for life under Charles II, during pleasure thereafter.² He received £100 per annum out of the treasurer of the chamber's office and a livery payment of £75 14s 3 1/2d. at the end of Charles II's reign. The sergeant trumpeter was also entitled to collect fees for performance at court ceremonials and creations. Gervase Price received an additional £60 'for breeding and instructing of boies'.³ At the end of the period this officer made £72 10s plus £65 10s 6d in fees of honour, £29 10s in fees from great officers, £20 in lieu of clothing and £5 10s in licenses.⁴

Trumpeters 1660-1837

The trumpeters were appointed by the lord chamberlain. They played on ceremonial occasions, including coronations, funerals, installations and proclamations of war, peace and new reigns. At the Restoration, fifteen trumpeters (in addition to the sergeant trumpeter) were established at a salary of £60 per annum apiece.¹ By the reign of William III this figure had risen to £91 5s.² The number of trumpeters was reduced to eleven in 1702, rose again to sixteen from 1727 to at least 1770, but fell to eight by 1782. According to an establishment of that year, their pay had fallen to £51 per annum. These officers also received their trumpets, livery every three years worth £8 6s 8d. apiece; fees of honour; and fees for performance at court ceremonials and creations.³ By the end of the period, each trumpeter made £46 plus £6 8s 2d in fees of honour, £1 1s 7d from great officers of state and £10 in lieu of clothing.⁴

Drummers 1660-1837

In 1660, the court was served by a drum-major general, a kettle-drummer, four drummers, a harper and a fife, all appointed by lord chamberlain's warrant. The drummers' positions seem to have been left unfilled 1685-1688. The harper and fife were eliminated in 1702. From about 1712 the drummers are referred to as drum-majors to specific household regiments (as opposed to the drum-major general). By 1758 there were five drummers and two kettle drummers.¹

These servants were paid £34 7s at the Exchequer until 1682, when they were transferred to the paymaster of the forces.² From this point the drum-major made £30 per annum, the drummers and fife £24 per annum. They also received livery of £16 2s 6d.³

The kettle-drummer made £ 91 5s under William III.⁴
