Hunting, Sporting and Gaming Establishment: The Buckhounds 1660-1837

The master of the buckhounds was appointed by royal warrant.¹ Cary's appointment in 1660 was embodied in letters patent under the great seal but this course was not followed in subsequent cases.² The office was left vacant between 1702 and 1709 (when it was transferred to the establishment of Prince George of Denmark) and between 1715 and 1727. Under Charles II, the master received an allowance of £2,248 to share with the sergeant and 34 huntsmen. Under William III this figure rose to £2,341 but this was reduced to £1,100 between 1709 and 1712.³

The sergeant made £200 per annum, huntsmen £40 per annum apiece in 1689.⁴

Master of the Staghounds 1738-82

This office was in the gift of the Crown. Appointments were made by warrant under sign manual. The salary was fixed at £1,600 in 1738 and at £800 in 1744.¹ The office was abolished in 1782.²

The Harriers 1660-1701, 1730-82

The office of master was in the gift of the Crown. Appointments were embodied in letters patent under the great seal until 1701 when the office lapsed. It was revived in 1730 as that of master of the harriers and foxhounds after which appointments were made by warrant under sign manual. It was left vacant 1751-4 and 1756-61 and was abolished in 1782.¹ Until 1702 the salary was £500.²

Five huntsmen (?appointed by the master) received livery of £3 16s and split £74 'among them' under Charles II. After 1730 £2,000 was provided for the establishment including the salary of the master and wages and allowances for the huntsmen.³

The Hawks 1660-1702

Under Charles II, the master of the hawks (or master falconer) made £390 per annum; the sergeant, £182; and 33 individual falconers anywhere from £20 7s 6d to £91 5s.¹ Under William III, the master of the hawks made £1500; the sergeant of the hawks £136; and ten falconers between £25 and £80 per annum. The establishment of the hawks was abolished at the accession of Queen Anne in 1702. Its master was awarded a pension.²

Guns and Bows 1660-1702

Under Charles II, two gentlemen of the guns made 12d per diem (£18 5s per annum). The Establishment of 1689 reduced their number to one at £140 plus £20 in livery money. Under Charles II, the gentleman of the bows made £85 5s. There were two yeomen of the guns and bows until 1675. The yeoman of the guns made £18 5s plus £15 6s 8d in livery money under William III. Under Charles II the crossbow maker made 4d per diem and (?)12s per annum. By 1720 the gentleman and yeoman of the guns were unpaid.¹

The yeoman of the leash made £3 6s 8d plus £52 per annum in livery under William III. The child of the leash made £2 plus £12 0s 8d for livery per annum.²

Game of the Bears and Bulls ?1660-1702

The establishment of the bears and bulls consisted of one master, one sergeant and one yeoman. Under Charles II they made a total of £48 12s 6d, to be apportioned among them.¹ In addition, there was a master of the game of cock-fighting. These offices seem to have been left unfilled in 1685, but the mastership of the bears and bulls was revived in 1688 only to be finally abolished at the accession of Queen Anne in 1702.

Groom Porter 1660-1782

The groom porter 'Has the Inspection of the King's Lodgings, and takes care that they are provided with Tables, Chairs, Firing, &c. As also to provide Cards, Dice, &c. when there is playing at Court: To decide Disputes which arise in Gaming.' He was appointed by royal warrant. Appointments were subsequently embodied in letters patent under the great seal.¹ The office was abolished in 1782.² In 1660 the remuneration consisted of wages of £2 13s 4d, board wages of £127 15s, lodgings, and fees from the 'oversight of common Billiards Tables, common Bowling Grounds, Dicing Houses, Gaming Houses and Common tennis Courts and power of Licensing the same within the City of London and Westminster or Borough of Southwark.'³ In 1702 the groom porter's fixed remuneration was raised to £550 from the treasurer of the chamber and £130 8s 4d from the cofferer.⁴

Master of the Tennis Courts c.1675-1837

The early history of this office is obscure. In 1675 when Thomas Cooke held it the reversion was granted to Horatio Moore who did not come into possession until Cooke's death in 1697. In 1689 Henry Villiers received a grant for the remainder of Cooke's life.¹ Appointments were embodied in letters patent under the great seal which granted the office during pleasure from 1708. The remuneration consisted of a salary of £120 and an allowance of 8d a day making a total of £132 3s 4d.²

Knight Harbinger 1660-1837

The knight harbinger and his subordinates below stairs were responsible for finding accommodation for the court while on progress. The knight harbinger was appointed by lord chamberlain's warrant.¹ Appointments were embodied in letters patent under the great seal granting the office for life until 1695 and during good behaviour thereafter. The remuneration consisted of 10s a day and 40 marks a year totaling £193 16s 8d a year. This officer was also allowed riding wages, and fees of honour which yielded around £60 per annum early in the

eighteenth century.²

Master of the Barges 1660-1837

The master of the barges was appointed by lord chamberlain's warrant. From 1660 to 1702 he received £30 per annum in wages. This rose to £100 under Queen Anne. By 1782 he made £100 plus £17 for livery and payment on bills which came to about £68 in that year. By the end of the period this officer held during good behaviour and his remuneration consisted of £82 plus a livery allowance of £22 9s 6d, £5 5s in fees on the appointment of individual watermen and £2 2s when called on to attend the House of Lords.

Late in the period the master of the barges (increasingly called the bargemaster) was also keeper of the swans.

Watermen 1660-1837

There were forty eight watermen plus as many as twelve watermen at pension all appointed by the lord chamberlain. Watermen made £3 per annum plus livery under Charles II. Their salaries were raised to £3 2s 6d. each under his successors, paid by the treasurer of the chamber. In 1782 their livery payment was estimated to be about £5 2s apiece.

The watermen at pension were, from 1830, to determine on the deaths of the incumbents.²
