**Household of Prince Augustus Frederick, (from 1801) Duke of Sussex
1773-c. 1789; c. 1803-1843**

By 1783, £11,000 was budgeted from the Civil List for the expenses of Princes Frederick, William, Edward, Ernest, Augustus, and Adolphus.¹ By 1830-31, the Duke of Sussex was paid £21,000 per annum (£6,000 out of the Consolidated Fund, £15,000 out of the Hereditary Revenues of the Crown).²
