Household of Caroline of Brunswick, Princess of Wales (from 1820, Queen) 1795-1821

At their marriage in 1795, £12,253 per annum was set aside out of the Prince of Wales's newly augmented revenue for the household expenses of Caroline, Princess of Wales. In 1820 she accepted the Crown's offer of £50,000 per annum in return for leaving the country.¹
